GENERAL PRODUCT WARRANTY

("EXTREMA") warrants to its authorized distributors of EXTREMA products and the original purchasers from such distributors, all products sold by EXTREMA to be free of defects in material and workmanship for a period to twelve (12) months from the date of delivery from its authorized distributors or 2000 hours of use, whichever occurs first. During said warranty period EXTREMA will, at its option, repair or replace any parts (or component part thereof) proving defective during said period. This warranty applies only to products, which are used in accordance with all instructions as to operation, maintenance and safety set forth in the catalogs, manuals, safety stickers, and/or instruction sets furnished by EXTREMA. EXTREMA's warranty is non-transferable.

This warranty does not apply to items that would normally be consumed or require replacement due to normal wear (abrasive belts, belts, blades, brakes, fuses, lubricants, sanding drums, etc.); to electrical motors and components which are warranted by their manufacturer; or the costs of removal, shipment for service and reinstallation. Claims relating to electrical components must be taken to the component manufacturer's local authorized repair station for service.

This warranty is null and void if the product has been subjected to (1) misuse, abuse, improper service or storage, use on any material other than wood; (2) accident, neglect, damage or other circumstances beyond *EXTREMA's* control; (3) modifications, disassembly tampering, alterations or repairs outside of *EXTREMA's* factory not authorized by *EXTREMA*; or to any product not bearing its original serial number plate; (4) damage caused by improper wiring or voltage; (5) damage of pneumatic components as a result of improperly dried or "dirty" air or lack of lubrication. *EXTREMA* strongly recommends the use of a REFRIGERATED air dryer to remove any moisture and other impurities from the air. Should circumstances prohibit you contacting the distributor then contact the *EXTREMA* factory directly. If your claim is covered by this warranty, your *EXTREMA* distributor will provide you with instructions as to how and where service will be provided. On simple warranty replacement or repairs, installation instructions will be provided to allow correction by customer personnel. *EXTREMA* assumes no responsibility for products that are returned without its prior written authorization. *EXTREMA*'s obligation under this warranty shall be exclusively limited to repairing or replacing (at *EXTREMA*'s option) parts which are determined by *EXTREMA* to be defective upon delivery, F.O.B.
